**OFFICE ORDER**

As per the Guidelines on UGC Regulations On Curbing the Menace of Ragging in Higher Educational Institutions, 2009 (Under Section 26(1) (g) of the University Grants Commission Act, 1956) Section 6.3 which inter-alia states that every institution shall constitute the following bodies; namely, **Anti-Ragging Committee** to be nominated and Headed by the Head of the Institution, and consisting of representatives of civil and police administration, local media, Non Government Organisations involved in youth activities, representatives of faculty members, representatives of parents, representatives of students belonging to the freshers category as well as senior students, non-teaching staff; and shall have diverse mix of membership in terms of levels as well as gender.

Accordingly an Anti-ragging Committee has been set up by the University to ensure compliance with the provisions of these regulations as well as the provisions of any law for the time being in force concerning ragging; and also to monitor and oversee the performance of the Anti-ragging Squad in prevention of ragging in the institution.


