- (iii) **INSTITUTIONAL MEMBER:** The institutional member shall pay an Annual subscription of Rs. 3000/- (Rupees Three Thousand only) and an admission fee of Rs. 50/-.
- (iv) **STUDENT MEMBER:** The Annual subscription for the student member shall be Rs. 25/- with an admission fee of Rs. 25/-.


Proposed amendment:

SUBSCRIPTION:

- (i) ORDINARY MEMBERS: Each ordinary member shall pay an Annual subscription of **Rs.100/-** and an admission fee of Rs. 25/-.
- (ii) LIFE MEMBERS: The life member shall pay **Rs. 1000/-** in one installment and an admission fee of Rs. 25/-.
- (iii) INSTITUTIONAL MEMBER: The institutional member shall pay an Annual subscription of **Rs. 6000/-** (Rupees Three Thousand only) and an admission fee of Rs. 50/-.
- (iv) STUDENT MEMBER: The Annual subscription for the student member shall be **Rs. 50/-** with an admission fee of Rs. 25/-.
