Sealed quotations are invited by the Registrar, The WB National University of Juridical Sciences for the work “Supply – Installation – Testing – Commissioning of 380 KVA Diesel Generator Set” (**Engine:** CUMMINS / KIRLOSKAR GREEN / KIRLOSKAR ELECTRIC and **Alternator** : Stamford / KIRLOSKAR ELECTRIC) from Manufactures / Authorized Dealers / Original Equipment Manufacturers (OEM) having good credentials for carrying out such work.

Tender documents may be seen from the above office. The same may be obtained during office hours from 18th to 21st March 2013 against application enclosing valid VAT, IT & PT clearance certificates together with certificate of good credentials on payment of Rs.500.00 in the form of Bank Draft in favour of WBNUJS. However, the authority reserves the right to reject any or all applications without assigning any reason thereof.

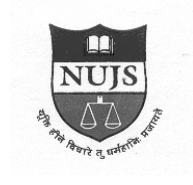
Quotations will be received on or before 22.03.2013 (up to 4 pm) and will be opened shortly thereafter. The sealed envelope should superscribe the name of work.

Quotations should accompany the NIQ & BOQ (along with technical specification) in original together with earnest money @ 2% of the quoted value in the form of Bank Draft in favour of WBNUJS.

Rates should be inclusive of all charges viz taxes, duties, transportation, loading, unloading etc. Itemised Rates should be quoted both in figures and in words. No conditional quotation and no quotation with price variation clause will be accepted. Validity of the offer is thirty days.

Total amount quoted for the work is the criteria for acceptance irrespective of rates quoted for individual items of work. However, acceptance of lowest or any other quotations is not obligatory. The authority reserves the right to accept or reject any or all of the quotations without assigning any reason thereof.

All materials, equipments, accessories must be as per latest IS. Manufacturer’s Test certificate should be produced on demand. Guarantee period is twelve months from the date of commissioning.



Payment terms: (i) Seventy five percent of the value of materials against supply of materials (ii) Ninety percent of the value of measured work after installation (iii) Hundred percent of the value of measured work after testing & commissioning.

Security Deposit: Ten percent of the bill value to be kept as security deposit and will released after three months from the date of commissioning.

The authority reserves the right not to undertake some items of work in the BOQ. The authority also reserves the right to increase or decrease the quantity as provided in the BOQ. Payment, however, will be made against measured work.

The authority reserves the right to undertake additional work, not provided in the BOQ, against additional payment based on market rate.

Time for completion of the work is 60 days from the date of work-order.
