One day National Seminar on "Legal Aspects of Uranium Mining in India: Issues and Concerns."

Fulfilling the requirement of uranium for the Pressurized Heavy Water Reactors, UCIL plays a very significant role in nuclear power generation of the country. UCIL is known for adoption of modern technologies for its mines and process plants. The Company operates six underground mines (Bagjata, Jaduguda, Bhatin, Narwapahar, Turamdih and Mohuldih) and one open pit mine (Banduhurang) in the State of Jharkhand. Ore produced from these mines are processed in two process plants located at Jaduguda and Turamdih. UCIL is constructing a new underground mine and process plant at Tummalapalle in Andhra Pradesh. The Company has taken up expansion of some of its operations in Jharkhand and started pre-project activities to set up new mines and plants in different parts of the country namely – Gogi in Karnatka, Lambapur in Telengana and KPM in Meghalaya.

SEMINAR CONCEPT NOTE

Uranium resources of the world is estimated to be 5.5 million tonnes and India forms 3% of the world resources. Most of the deposits found in India fall under the low grade category and are distributed mainly in areas of Jharkhand, Chhattisgarh, southern parts of Meghalaya, Cuddapah Basin, Andhra Pradesh, Telangana, in parts of Karnataka and Aravalli – and Delhi Supergroups, Rajasthan and Haryana. India started its uranium exploration in the early fifties and the first deposit to be discovered was at Jaduguda in 1951 in Sighbhum Shear Zone (SSZ). Subsequently, under the aegis of Uranium Corporation of India Ltd. started mining uranium from 1967.

India currently imports uranium from Kazakhstan, Russia and Canada and plans to purchase the fuel from Australia. India has also signed an agreement to procure more uranium from Uzbekistan. In spite of the opportunities to import fuel, India continues to prefer the ideal path of generating power using indigenous uranium. Currently, India is dependent on the number of mines in Jharkhand (six underground mines - Bagjata, Jaduguda, Bhatin, Narwapahar, Turamdih and Mohuldih and one open pit mine – Banduhurang), however, with ambition to increase its capacity and encourage the use of energy efficient resources India plans to expand and dig more mines in areas of Andhra Pradesh (Tummalapalle), Karnataka (Gogi), Telangana (Lambapur) and Meghalaya (Kyelleng-Pyndengsohiong, Mawtahbah).

In the light of the aforementioned, WBNUJS in collaboration with UCIL is organizing a One-day National Seminar on the topic titled "Legal aspects of Uranium Mining in India: Issues and Concerns". The guiding questions that the seminar attendees would seek to address and answer are:-

- 1. Why it is crucial to address the problem identified, i.e. the sustainable development in terms of the project/uranium mining vis-à-vis the environment protection?
- 2. What has already been done to solve the problem of abatement with respect to the mining project?
- 3. What are the ideas/plans that can be adopted from other similar jurisdictions and areas?
- 4. How to balance the rights of the indigenous people whose lands and forests have been/would be acquired for mining?

5. Are there any scientific exploratory ideas that would harmonize the balance between the rights					
of the indigenous people and the development through the uranium mining?					
Probable solutions and proposals to hindrances faced by the various stakeholders, including the indigenous people and the UCIL involved in the mining activity, the publication of information materials, and the papers presented and ideas projected would be the sought after objectives.					

THEMES AND SUB-THEMES

The themes of discussion seek to explore a broad set of law, policy and governance issues related to the mining sector besides other contemporary issues relating to mining like its interplay with the environment and the applicable laws in this regard, the interface of judicial review, envirolegal issues, interconnecting technology with transparency- augmentation through the e-bidding process etc.

INTERPLAY BETWEEN MINING & ENVIRONMENTAL REGIME: ISSUES & CHALLENGES

- Analyzing the recent Sustainable Development Framework for mining of radioactive elements,
 viz. uranium in India.
- Environmental Clearances and Procedures with respect to the mining of radioactive elements.
- International policies and perspective on atomic energy laws: Stockholm to Paris.
- Reclamation & Rehabilitation including the rights and interests of the marginalized groups.
- Incentives encouraging good mining practices, technology absorption and the exploitation of deep-seated minerals: examining proposals.
- Role and Significance of the courts & tribunals in environmental protection vis-à-vis atomic energy development.
- Role and Significance of the civil society organizations in the Mining Sector of radioactive elements.
- Constitutional perspective of nuclear energy regime.
- Problems of land acquisition in India vis-a-vis mining sector of the radioactive energy sector.
- Status of Reconnaissance Permits, Prospecting Licenses and Mining Leases with respect to extraction of radioactive elements in India.
- Forest Rights and the Indigenous People's Rights: Land acquisition for the abovementioned purposes.
